TENDER FOR HIRING OF MANPOWER ON OUTSOUCED BASIS  
NOTICE

This is furtherance to opening of Technical Bids on 06.06.2016 It has been observed that in the Proforma for Financial Bid of Tender Document for Hiring of Manpower on outsourced basis, Service Charges per month are inadvertently mentioned as to be quoted in "RUPEES" whereas the nature of work is such that the Service Charges per month has to be in "PERCENTAGE". Accordingly, the Competent Authority has decided to call for fresh sealed Financial Bids from the successful Technical Bidders (as per our Notice published on our website on 08.06.2016) in the enclosed format.

Hence, the opening of Financial Bid scheduled on 09.06.2016 is postponed to 20.06.2016 at 3.00 P. M. All the successful Technical Bidders (as per our Notice dated 08.06.2016) have to re-submit their Financial Bid in Percentage as per new proforma which is enclosed, by 3.00 P. M. on 17.06.2016. The fresh Financial Bid in the new Proforma shall be duly sealed in single envelop super scribed as "SUPPLY OF MANPOWER ON OUTSOURCED BASIS - FINANCIAL BID". Unsealed Financial Bids will be outrightly rejected.

The earlier submitted sealed Financial bids may be collected from DGM at 21<sup>ST</sup> Floor, Ambadeep Building, 14 Kasturba Gandhi Marg, New Delhi on any working day during 11.00 AM to 4.00 P. M. The person coming for collecting the financial bid shall be duly authorized and mandatorily submit copy of valid I-card.

Failure to re-submit the Financial Bid by the time and date mentioned above, in new proforma by any successful Technical Bidder shall be deemed that they are not willing to participate in the Bid Process and their Tender shall be rejected.
